## Engineering Design Approach

JDB design philosophy is to provide quality work, on time and within budget. This goal is accomplished through strong communication with the client, the user and total project design and construction staff.

JDB s staffs know that our clients should not have to become experts to oversee projects, that s why you retain us. We strive to make our clients project manager s job easy, by keeping them informed and by doing our job well.

Our Staff meet with and listen to clients from a project s onset and continue through completion. We send timely notification of meetings and document our field visits and meetings, issuing meeting and teleconference minutes within five working days.

We review the program at the site to investigate the challenges it presents in meeting the program, then discuss any impact these challenges might pose with you, our client, along with possible alternatives for overcoming the challenges. We meet together with you to develop the solution. We visit the site again with plans prior to 50% completion on small projects and 35% on larger ones. to verify that field construction conditions that could make the design solution difficult and expensive have been adrdressed in the design.

JDB meet with the client's project manager and the user at the site with 90% review documents. We want to know you are satisfied. Our communication continues as we meet at the site with prospective contractors, apprising them of the process we used to develop the design solution and any difficul site conditions. We believe not only in clear communications with you, we also believe in providing quality work. We do not expect our clients to be our quality control person and are very dilient regarding our design. If we discover that an item has been ommitted from documents or that there are errors, we notify our clients in a timely manner.

# Construction Management Approach

# **Contracting Strategy**

JDB develops a formal contracting strategy after consultation with the client. ### **CPM Scheduling**

JDB's scheduler develops a detailed CPM master schedule that encompasses both design and construction. Designers and contractors contribute schedule data for JDB to incorporate into the master schedule.

The schedule includes weekly review meetings, so Project Manager is always aware of schedule status, and can implement corrective actions when necessary.

JDB's scheduler tracks the construction schedule by making weekly comparisons of planned work against actual progress. We prepare weekly activity schedules based on results of weekly progress meetings and uses these as a tool to monitor progress.

In return, JDB anticipates that these Preferred Suppliers will always submit the most economic costing, work safely and continuously improve their delivery performance. Performance of the Supply Chain will be monitored and reported regularly.
